The Karnataka State Higher Education Council, National Stock Exchange (NSE) and Bengaluru City University is jointly organizing a Faculty training program on "Financial Education and Investment Awareness" Course on 23<sup>rd</sup> and 24<sup>th</sup> September 2022 at Jnana Jyothi Auditorium, Bengaluru City University. Eminent Resource Persons from National Stock Exchange Academy will be mentoring the faculty members on the said theme. This course will be taught as a Core paper in the second year Undergraduate degree Program (3<sup>rd</sup> / 4<sup>th</sup> semester).

As per the guidelines of KSHEC, every selected faculty member will be given a total of 24 hours of training (12 hours of offline and 12 hours of on-line training). During the scheduled two days, the faculty members are given hands-on training of 6 hours duration each day. On-line training will be scheduled by NSE during weekends.
