Bengaluru City University invites applications for various types of affiliation for the academic year 2023-2024 as prescribed now sections 59 & 62 of the KSU act, 2000, from the affiliated Colleges/Managements situated in the Bengaluru City University jurisdiction as specified in the Karnataka State Universities (Amendment) act, 2015 i.e., Karnataka Legislative Assembly constituency of Shanthinagar, Byatarayanapura, Yelahanka, Malleshwaram, Hebbal, Shivajinagar, Gandhinagar, Chamrajpet, Chikpete, Basavanagudi, BTM Layout, Jayanagar and Rajajinagar of Bengaluru District.

1. RENEWAL OF AFFILIATION:

Applications are invited for renewal of affiliation to the existing courses, additional courses and enhancement of intake in the existing affiliated Colleges under the Faculties of Arts, Science, Commerce & Management and Education. The Colleges intending to apply for renewal of affiliation / enhancement of intake to BHM, MBA & MCA, should obtain prior approval of AICTE, for BASLP, MASLP or B.Sc/M.Sc (Speech and Hearing) from rehabilitation Council of India. For B.Sc.Ed/B.A Ed/B.Ed/BP.Ed/M.Ed Colleges from NCTE as applicable.

NAAC Accreditation: As per the State Government circular No.76 UBV 2011 Bengaluru dated 17.05.2011 the Colleges which have completed 5 years are inform to adhere to the standards circulated by NAAC compulsorily and obtain a minimum of 'C' Grade. The Principals of all the Colleges have to make efforts to adhere to the directions of the State Government issued time to time. Renewal of affiliation to such Colleges for the academic year 2023-24 is subject to NAAC accreditation of 'C' Grade.

2. AFFILIATION OF ADDITIONAL COURSE:

The Colleges can apply for affiliation for starting of additional courses under the Faculties of Arts, Science, Commerce & Management and Education. Colleges should seek affiliation to only approved UG courses and subjects. For Starting of PG Courses: Colleges having infrastructure facilities as per guidelines (available in the University website) for permitting Post Graduate courses in affiliated Colleges are eligible to apply for fresh affiliation to start PG courses. The Govt. Colleges should have prior permission from Dept. of Collegiate Education to apply for PG courses. There is no need to submit separate application for PG courses.

The following requirement of land as per the directions of Government of Karnataka vide order No. ED 34 EGOV2020 (Part -2) Bengaluru dated 26.04.2022 shall be mandatory for starting New College/Additional Courses/Subjects/Intake Enhancement etc..

Note: The authentic documents of limit Registered sale deed and Katha extract shall be enclosed / uploaded.

3. ENHANCEMENT OF INTAKE:

The Colleges can apply for enhancement of intake to the courses under the Faculties of Arts, Science, and Commerce & Management. In case of PG courses, colleges should note that they shall not seek enhancement of intake to PG course more than the intake fixed in the University PG Department of Studies. The requirement of land as mentioned in the Sl. No. (2) Shall apply for additional intake.

4. FRESH AFFILIATION TO START A NEW COLLEGE

The Management /Societies /Trusts registered under Societies Registrations Act/Trust Act, are eligible to apply for Fresh affiliation to start new Colleges for approved courses and subjects only within the Bengaluru City University jurisdiction. The requirement of land as mentioned in the Sl. No. (2) shall apply for Fresh affiliation to start a new college which has been posted in the University website.

5. PERMANENT AFFILIATION/CONTINUATION OF PERMANENT AFFILIATION(EXCLUDING PG COURSES)

<u>Permanent Affiliation:</u> As per section 62 of KSU Act 2000, the colleges affiliated to Bengaluru City University continuously for a period of not less than 5

years and fulfilling the conditions of affiliation and attained the academic and the administrative standards on an average stipulated by the University from time to time shall be eligible for grant of Permanent affiliation. As per GO No. ED 37 UBV 2007 dated 09.04.2007, colleges must be accredited with at least 'C' Grade by NAAC.

Renewal of Permanent Affiliation: The Colleges which have completed terms of Permanent affiliation shall apply for renewal of Permanent affiliation.

The College should submit application for Permanent Affiliation/Renewal of Permanent affiliation and renewal of affiliation for the courses/Subjects not covered in Permanent affiliations along with the prescribed fees.

The Government vide circular No. ED 227 URC 2017 dated 07.07.2017 have specified the period of Permanent affiliation as 5 years, 4 years and 3 years for the colleges which have been accredited with A,B, & C grade respectively by NAAC. The Colleges have to apply for renewal accordingly. After completion of specified period.

6. SHITING/CHANGE OF NAME/CHANGE OF MANAGEMENT ETC.,

Requests for shifting of colleges, change of Name/Management, will be considered under section 59 (5) of the KSU Act 2000. Colleges willing to apply for the same should submit separate application, with copies of relevant documents such as, a) Resolutions of Governing Body/Trust of the Colleges, b)Building Plans, sale/Lease deed, c) NOCs from other Departments, if any, etc,. as required, along with prescribed fee.

Note: (i) Colleges / Managements should note that the permission for Change of Name/Management etc,. has to be approved by the state Government (ii) The conditions of requirement land as mentioned in Sl No. (2) shall apply for shifting of Colleges also.

8. <u>AFFILIATION/APPLICATION FEE AND SUBMISSION OF APPLICATIONS</u>

The affiliation fee as notified in the notification (for SC/ST Colleges / Management, affiliation fee payable is 50%, as per Government order No.ED 21 UBV 2004 Bangalore Dated 15.05.2004) has to be paid through RTGS/NEFT/ONLINE.

After submission online application 3 copies of the printouts along with enclosures in all respects (along with preliminary project report, in case of additional PG courses, if any) are to be submitted in person, with the documents RTGS/NEFT/ONLINE paid receipt towards affiliation/application fees Rs. 2200/-

(without fine) on or before 16.05.2023 application with (late fee of Rs. 11,000/- per day will be accepted) up to 25.05.2023 (4PM) at the office of The Registrar (Academic Section), Bengaluru City University, Central College Campus, Bengaluru – 560001.
