Application are invited from the eligible candidates for admission to Ph.D. (Full-time and Part-time) programme offered in the following subjects: **Kannada, English, History, Economics, French, Commerce, Management, Chemistry, Bio-chemistry, Mathematics, Food Science & Nutrition, Life science, Botany, Physics, Electronics, Psychology, Human Development, Computer Science, Biotechnology & Education** in the prescribed form (Form A & Form B) available in the www.buc.ac.in website. Eligible applicants are advised to download the application and submit the duly filled application to the University also fill the same in the Google form provided in the link <https://forms.gle/MTisdJFTFHckGTxH9>.

The candidates shall submit the hardcopy of the offline dully filled application with all mandatory enclosures to: **The Office of the Registrar (Evaluation), Central College Campus, Bengaluru City University, Dr. Ambedkar Veedhi, Bengaluru –01.** The prescribed application fee for GM and OBC candidates appearing for entrance test is Rs. 3,300/- and Rs. 2,200/- for Non-Entrance candidates. Application fee for SC/ST/Cat-I / PwD candidates whose annual income is less than Rs. 2,50,000/- is Rs. 1,650/- for Entrance candidates & Rs. 1,100/- for those Exempted from Entrance Test. Application fee for Eligible Foreign Nationals is Rs. 11,000/-. Fee remitted through Demand Draft drawn in favour of The Finance Officer, Bengaluru City University.

Procedure for Offline Submission of Application Form:

- Candidates shall visit the University Website www.bcu.ac.in for Application Form.
- Candidates shall fill the required details in the Application Form and submit it offline.
- For successful registration of application form, candidate shall upload a valid scanned copy of the recent passport size photo, communication details, valid e-mail address and education details in <https://forms.gle/MTisdJFTFHckGTxH9> link.
- The candidates shall also pay the prescribed fee through Demand Draft in the favour of the Finance Officer, Bengaluru City University, Bengaluru.
- Thereafter, the candidates shall submit one set of duly filled in hard copy of Application Form to the **Office of the Registrar (Evaluation), Natural Science Block, Central College Campus, Bengaluru City University, Dr. Ambedkar Veedhi, Bengaluru -01.**
- The Applicants can also send the applications through Post with all the relevant documents along with **Demand Draft** (on the post mention “**Ph.D. Application for _____**”) to the **Registrar (Evaluation), Natural Science Block, Central College Campus, Bengaluru City University, Dr. Ambedkar Veedhi, Bengaluru - 560001.**
- Incomplete/ineligible Applications and Applications received after the last date shall automatically stand rejected and no communication regarding the same will be made to the candidates.

Enclosures:

The copies of the following documents shall be enclosed along with the application form.

- a. Copies of marks card and degree certificates of Under Graduate, Post Graduate / M.Phil. degree course work examinations (wherever applicable).
- b. Copy of the Caste certificate in case of SC/ST/Category-I and caste cum income certificates in the case of Category – II-A/II-B/III-A/ III-B candidates, in the case of HK reservation Hyderabad Karnataka region certificate, Persons with disability (PwD) certificate indicating the percentage of disability of candidates.

- c. Documents pertaining to UGC/ CSIR-JRF / NET/ K-SLET / GATE (with validity period and required score)/ Recognized young researchers by DST, UGC, CSIR/AICTE, QIP/INSPIRE/ DBT/ National Funding Agencies/ M.Phil. (regular mode)/ Teachers with QIP/ Foreign candidates fulfilling the requirements of eligibility vide Ph.D. Regulations 2016 (Amendment 2023) (wherever applicable).
- d. However, selected candidates have to submit Migration Certificate (Outside Karnataka) and Eligibility Certificate (Foreign Students) at the time of registration.
- e. Proof for having paid the required fees i.e. fee payment receipt.
- f. If any Candidate provides false information about his/her educational credentials, income caste, etc, the University has right to cancel his/her application and register a criminal case in the Police Station.

Eligibility Conditions

The candidates must have a Master Degree from UGC recognised Educational Institution or an equivalent degree from a Foreign Educational Institution with at least 55% in aggregate/equivalent grade points. A Maximum relaxation of 5% of marks may be allowed for those belonging to SC/ST/Cat-I/PwD.

If the results of Master's Degree are declared in the form of grades / credits / cumulative grade points in their marks cards / transcripts, such grades/points shall be converted into percentage to assess the minimum eligibility criteria.

Entrance Test

The University will conduct an Entrance Test of 120 minutes duration for a maximum of 100 marks. The entrance test shall consist of 10% questions pertaining to research methodology and 90% pertaining to the specific Subject. The Test will be of 50 multiple choice Questions carrying 2 marks each. The candidates must secure 50% marks in entrance test to be eligible for admission to Ph.D. programme, subject to availability of vacancy under the respective category.

Non-Entrance Candidates

The candidates who have cleared UGC/CSIR-JRF/NET/K-SLET/GATE (with valid period with required score)/ Recognized young researchers by DST, UGC, CSIR/AICTE, QIP/INSPAIR/DBT/National Funding Agencies/M.Phil. (Regular mode)/ Teachers with QIP/ Foreign candidates are exempted from entrance test. However, the eligible candidates qualified in UGC/ CSIR JRF/ AICTE/ QIP/ DST/ INSPIRE/ National Level Funded Projects with fellowships and ICCR sponsored foreign national may apply any time to the University for admission to Ph.D. programme. Candidates who are exempted from entrance test may also apply for both streams by submitting separate applications (Form A & Form B).

Consolidated Merit List

Entrance Category: The Merit list of candidates who scored a minimum of 55% & above under the GM & OBC category & a minimum of 50% and above under SC/ST/Cat-I/PwD will be prepared & Notified. In the event of tie in entrance score, percentage score in the qualifying examination shall be considered for ranking.

Non-Entrance Category: The merit list of the candidates who have cleared UGC/ CSIR-JRF/ NET/ K-SLET/ GATE (with validity period with required score)/ Recognized young researchers by DST, UGC, CSIR/AICTE/QIP/INSPIRE/DBT/National funding Agencies. etc., shall be prepared based on marks secured at Post-Graduate Level. In case of tie in the percentage, within subgroups, seniority by birth shall be criterion for ranking.

An interview/Viva-voce shall be conducted by the University / Department to assess the research interest, communication skills, analytical skills and depth of knowledge in the concerned subject.

Candidates will be selected for admission from both entrance and exempted stream in a 50:50 ratio based on overall performance in entrance test and Viva- Voce with weightage ratio of 80:20%.

In case of entrance exempted candidates, weight age of 80% and 20% shall be given to marks scored at qualifying exam and Viva-Voce respectively. The final merit list will be valid until the next Ph.D. notification.

Course Work Procedure:

After Provisional Registration, all the registered candidates shall take up the course work in the respective P.G. Department/ Research Centres. The full time and the part-time candidates have to complete the course work in a semester on full time basis. In exceptional cases, the part time research candidates may be allowed to complete the course work in two semesters. During full time course work, the candidates shall take papers I, II & III and work on the Research Proposal under the supervision of the guide in the first semester. In the part time course work, the candidates shall take papers I, II, & III in the first semester and work on the Research Proposal in the second semester.

The candidate fulfilling the prescribed eligibility criteria alone shall apply for Ph.D. programme and shall produce all the original Marks cards, caste certificate, 371J certificate for HK region/ relevant order for claiming exemptions from Entrance Test etc., at the time of admission/ counselling for verification along with one set copies of all the said documents, failing which, the candidates will not be considered for admission to Ph.D. Programme in spite of his / her passing entrance test or claiming eligibility under non-entrance category.
2. Reservation in admission for SC/ST/Cat-I/PwD and OBC candidates will be provided as per the Regulations governing the Degree of Doctor of Philosophy of Bangalore University 2016 (Amendments 2023)/ Government Orders.
3. Research centres must strictly adhere to the UGC/ BU Guidelines/ regulations issued from time to time.
4. Management must give an undertaking stating that they will not relocate the Research Supervisor until the submission of the Ph.D. thesis of the candidates working under the Research Supervisor. Research Supervisor must give an undertaking that they will not relinquish the Supervisorship under any circumstances until the submission of Ph.D. thesis of the Allotted candidates.
