

Faculty Training Proposal for "Financial Education and Investment Awareness" course

Highlights of the training

- 1. Programs to be launched on 5th September, on Teachers' Day
- 2. All programs to be completed before the festive season in October
- 3. Each program is of 24-hour duration (@ 6 hrs each day) 2 days in classroom format and 2 days in live online format
- 4. The classroom sessions are on weekdays to the extent possible
- The online sessions will be on every weekend and the faculty members can attend on any day according to their convenience (subject to maximum participation limit per program)

Responsibility of the University

- 1. Notify the course as core course to be taught in II year UG degree program (3rd Sem / 4th Sem)
