NOTIFICATION

Bengaluru Central University invites application for affiliation as prescribed under Sections 59 and 62 of KSU Act, 2000 for the affiliated Colleges / Managements situated in the Bengaluru Central University jurisdiction as specified in the Karnataka State Universities (Amendment) Act, 2015 i.e., Karnataka Legislative Assembly constituencies viz., **Shanthinagar, Byatarayanapura, Yelahanka, Malleshwaram, Hebbal, Shivajinagar, Gandhinagar, Chamarajpet, Chickpet, Basavangudi, BTM Layout, Jayanagar and Rajajinagar.**

1. RENEWAL OF AFFILIATION:

Applications are invited for renewal of affiliation to the existing courses, additional courses and enhancement of intake in the existing affiliated Colleges under the Faculties of Arts, Science, Commerce & Management and Education. The Colleges intending to apply for renewal of affiliation / enhancement of intake to BHM, MBA, MCA should obtain prior approval of AICTE; for BASLP, MASLP or B.Sc. / M.Sc. (Speech & Hearing) from Rehabilitation Council of India (RCI), and for **B.Ed /B.P.Ed/M.Ed /M.P.Ed** Colleges from NCTE as applicable.

NAAC Accreditation: As per the State Government Circular No.76 UBV 2011 Bangalore, dated 17.05.2011, the Colleges which have completed 5 years are requested to adhere to the standards prescribed by NAAC; and to obtain a minimum of C grade in the NAAC accreditation. The Renewal of affiliation to such Colleges for the academic year 2019-20 is subject to NAAC accreditation of atleast 'C' grade. Further, the Principals of all the Colleges have to make efforts to adhere to the directions of the State Government issued from time to time.

2. AFFILIATION OF ADDITIONAL COURSE:

The Colleges can apply for affiliation for starting additional courses under the Faculties of Arts, Science, Commerce & Management. The Courses can be mentioned in renewal of affiliation application form. Colleges should seek affiliation only to approved combinations of Under Graduate Courses.

For starting of Post Graduate Courses:

The eligible Colleges intending to apply for affiliation to P.G. Programmes have to mention the P.G. Courses in Renewal of affiliation application and have to submit a preliminary report showing the infrastructure and other facilities available for each programme, with proof of sufficient financial and other resources for sustaining the programme along with the application.

The Government Colleges should have prior permission from the Department of Collegiate Education to apply for P.G. Courses.

3. ENHANCEMENT OF INTAKE:

The Colleges can apply for enhancement of intake to courses under the Faculties of Arts, Science, Education, Commerce & Management. **In case of P.G. courses, colleges should note that they are not permitted to seek enhancement of intake to P.G. Course not more than the intake fixed in the respective University P.G. Departments of Studies.** In the case of Education Programme, the prior sanction of NCTE is required.

4. FRESH AFFILIATION TO START A NEW COLLEGE (EXCLUDING POST GRADUATE COURSES):

The Management / Society / Trust registered under Societies Registration Act / Trust Act, are eligible to apply for Fresh affiliation to start new Colleges with a minimum of two Courses for the academic year 2019-20 (in the approved UG Courses / combinations only). The applications may be obtained from the Office of the Registrar, Bengaluru Central University, Central College Campus, Bengaluru.

Who are intend to start a new college, application may be obtained from Office of the Registrar, Bengaluru Central University, Central College Campus, Bengaluru -560 001, on payment of prescribed fee notified in the website : www.bcu.ac.in from 16-02-2019 to 25-02-2019 in favour of Bengaluru Central University, Bengaluru- 560 001

Note: Management / Society / Trusts are not permitted to apply for affiliation to M.Ed/ M.P.Ed B.Ed / B.P.Ed Course as per the NCTE directions.

5. PERMANENT AFFILIATION / CONTINUATION OF PERMANENT AFFILIATION (EXCLUDING P.G. COURSES):

The Colleges affiliated to Bangalore Central University continuously for a period of not less than 5 years and fulfilling the conditions of affiliation and attained the academic and the administrative standards on an average stipulated by the University from time to time shall be eligible for grant of permanent affiliation. As per G.O.No. ED 37 UBV 2007 dated:- 09.04.2007; Colleges must be accredited with atleast C grade by NAAC.

Renewal of permanent affiliation: The colleges which have complied with the terms of Permanent Affiliation shall apply for renewal.

It may be noted that the Government vide Circular No. ED 227 URC 2017 dated 07.07.2017 have specified the period of permanent affiliation as 5 years, 4 years and 3 years for the colleges which have been accredited with A, B and C grade respectively by NAAC.

8. AFFILIATION FEE:

The detail of affiliation fee is annexed to this notification (For SC / ST Colleges / Managements, affiliation fee payable is 50%, as per Government Order No. ED 21 UBV 2004 Bangalore dated 15.05.2004). Payment of Affiliation fee will be made through online in favour of "Bengaluru Central University, Bengaluru- 560 001".

Note: (1) Refund of affiliation fee is as per the revised Statutes pertaining to affiliation of Colleges / Institutions;

(2) Fee paid by the College towards in-eligible courses are not refunded / adjusted.

Note: Additional 18% of GST on Affiliation fee shall have to paid by the colleges as and when it is made mandatory by the Government.
