Applications are invited from the Post Graduate Department of studies of the affiliated Colleges / Laboratories / Institutes / Research Centres within the jurisdiction of the Bengaluru City University (BCU) for seeking recognition as Research Center for the purposes of carrying of the Research Programme in their respective subjects in the streams of Humanities, Languages, Science, Commerce, Management and Education and to conduct Ph.D Programme according to the Regulations of the Bangalore University which are applicable to the University.

- i. Institutional Eligibility for P.G. Departments in the affiliated colleges including autonomous colleges / Laboratories / Research Institutes where necessary facilities for Research work and qualified staff are available to guide research students.
- ii. Research Laboratories of all India nature/ Institutions maintained by the Government of India.
- iii. Research Institutions maintained by the State Government or quasi Government / Autonomous Institutes recognized by the Central or State Government having necessary facilities, laboratory for research work and having qualified staff Scientists to guide research students.
- 1) Application format may be downloaded from the University Website <u>www.bcu.ac.in</u>. The filled in application formats along with enclosures are to be submitted to the University in 5 Sets with DD for ₹ 1,00,000/- per subject in favour of "Finance Officer, Bengaluru City University, Bengaluru" (DD to be submitted to the Finance Branch of BCU). Separate application and fees are to be submitted for recognition of each research centre.

- 2) The Colleges / Institutions who have already been recognized as research centre by the Bengaluru City University and completed / completing 4 years recognition period have to submit the application form along with enclosures in 5 Sets for renewal of recognition as research center along with the prescribed fee of ₹ 40,000/- in the form of DD in favour of "Finance Officer, Bengaluru City University, Bengaluru". Separate application shall be submitted for each subject along with fee.
- 3) The Colleges / Institutions who have already been recognized as research centre by the Bengaluru City University for period of four years, shall pay annual fee ₹ 15,000/- per subject / per year in the form of DD in favour of "Finance Officer, Bengaluru City University, Bengaluru".
- 4) The Colleges are required to remit the DD in the Finance Section and enclose the original receipt to the application format.
 - * The Colleges / Institutions managed by the State Government or Central Government are exempted from payment of fee. There will be 50% concession in the recognition fee for the SC/ST Managements / Institutions.

Conditions for Recognition

- 1. Separate application and fees shall be paid for each subject.
- 2. If the application is withdrawn before the schedule of Expert Committees visit or if fresh recognition is not granted, only recognition fee shall be refunded.
- 3. There shall not be any refund of recognition fee when applied for renewal or for introduction of new subject in the existing College / Institution / Center after the visit of Expert Committee.
- 4. If the Society / Trust / Institute / College fails to start the Research Center or new subject in the existing recognized research center during the year for which recognition is granted, recognition may be renewed on receipt of the application with usual annual renewal fee for the subsequent year.
- 5. The College seeking recognition as Research Centre should have the required academic administrative & research infrastructure and supporting administrative facilities.
- 6. Post Graduate Department of Colleges, Research Laboratories of Government of India / State Government, should have at least two qualified teachers / scientists and adequate infrastructure, academic administrative support research facilities and library as per the Regulations.

The last date for submissions of filled in application along with enclosures and prescribed fee (without late fee) is 20.11.2023 and with late fee of ₹ 5000/- is 29.11.2023.

Important Notes:

- 1. Incomplete applications (including part payment) will be rejected. Expert Committee will not visit such Institutions / Centres.
- The Head of the Colleges / Institutions must ensure that full payment of recognition fee through DD shall be paid at the time of submissions of applications to the University.
- 3. Once the applications is rejected, it will not be considered again for the current year.
