In this regard, the following procedures are to be followed.

- (a) After declaration of results, if any candidate wishes to apply for <u>Challenge Valuation</u> may do so within the dates as mentioned below by visiting UUCMS portal (b) Then click online payment. link will be connected to Student Portal (c) Then select <u>Challenge Valuation</u> menu and enter the correct Register No. the Name, College Name, Course Name, Semester will be displayed automatically. (d) Then Student has to select <u>Challenge Valuation</u> option. (e) Then the paper code details will be displayed. Student has to select the number of papers for <u>Challenge Valuation</u>. (f) Then click on pay fee button to get payment option. (g) Now students can pay by UPI/Credit/Debit Card and Net banking. (h) After successful paymentreceipt will be generated. (i) After generating the Receipt.
- 2. There is No Re-totaling for P.G. Courses.
- 3. Fees once paid for <u>Challenge Valuation</u> will not be refunded or adjusted for future Examinations.

Procedure for applying Challenge Valuation:

- 01: Students should login with their (UUCMS) User Name and Password.
- 02. Click on the "Exam application" to View the results in the Student Portal.
- 03. Click on the Exam > "Exam Re-evaluation" tab who desire to apply for Challenge Valuation.
- 04. Prescribed fee will be displayed in the portal itself for each Subject
- 05. Students should select the subjects for which they desire to Apply for Challenge Valuation.

- 06. Select the Payment type and Click on the Pay fee button to pay fee the Application Form.
- 07. A unique Application number will be generated Students should take the print out of the Application Form for further correspondence.
