Whereas, it was considered necessary to amend the Karnataka State Universities Act, 2000 (Karnataka Act 29 of 2001), to bring reforms in the governance and administration of the Bangalore University and improve academic quality by Trifurcating it into "Bengaluru University", the new University called "Bengaluru Central University" and the another new University called "Bengaluru North University".

Whereas, the Karnataka State Universities (Amendment) Act, 2015 was enacted by the Karnataka State Legislature in the sixty-sixth year of the Republic of India and the Karnataka State Universities (Amendment) Act, 2015 was first Published in the Karnataka Gazette Extra-ordinary on the Thirteenth day of August, 2015.

Whereas, "Bengaluru Central University" and "Bengaluru North University" were came to be newly established as Affiliating Universities.

Now, therefore, Government of Karnataka has accorded approval for commencement of Bengaluru Central University and Bengaluru North University with effect from 01.07.2017 in the Academic Year 2017-18

The territorial jurisdiction of the new Universities shall be as provided in the Karnataka State Universities (Amendment) Act, 2015.
